## St. Michael Historical Society Minutes: August 11, 2014

**Public Relations** – Crystal had nothing new to add for Public Relations.

**Newsletter** – Bob reported that the newsletter was out and that he was already coming up with some possible ideas for the next newsletter. These include the 100<sup>th</sup> anniversary of the old rectory, something on the old cemetery being a monument to St. Michael's founders, and an article on Father Balta.

**Membership** – Sheldon reported that the society has a total of 98 members.

**Curator** – Bob has been doing a lot of cataloging, it's slow but he has made some progress. Some historical pieces were brought in by some of our own board members.

**Old Business** – The search for an artist to do a 10 year anniversary print for the society is still ongoing, the search was tabled till next month's meeting. Wayne Mosher was not present at the meeting, so his information was tabled till next month. Booth availability for the church festival was checked on by Bob and there is space available for the society.

**New Business** – people were assigned to sit at the Society's booth at the church festival. Memo cards would be available there, as well as membership applications and orders for the 1931 Church Jubilee photo. A price of \$20 was agreed upon to sell the photos.

**Announcements** – The old timers' round table will be at next month's meeting. The next meeting will take place on September 8, 2014 at 7:00 PM in the Library Conference Room.

Adjournment - Harry motioned to end the meeting, Lisa 2nded the motion. The motion carried.
